What is Payroll Giving?



Payroll giving is an easy and efficient way to give to the charities you care about right from your Gross Pay. It's also sometimes known as Give as You Earn.

This is a tax-free way of giving from your paycheck allowing your donations to go even further. For example, if you're a standard rate taxpayer, a £10 gift will only cost you £8, and if you're a high rate taxpayer it will only cost you £6.

Payroll Giving is very easy to set up through your payroll department and will automatically stop if you change jobs.



How does payroll giving help the Home?

Our mission is to find loving homes, protect loving homes and run a loving Home for the people and pets who need us.



This means we give everything possible to keep pets where they belong and prevent them from coming through our doors in the first place. And when they do come to us, we give everything we can to help them get healthy, strong and into loving new homes, where they belong.

It costs around £3 million a year to run Edinburgh Dog and Cat Home we receive no government funding, relying almost entirely on the generosity of donations from the public.

Supporting our work in a regular way like through Payroll Giving allows us to plan for the future and focus on providing the best possible care and support for the people and animals who need us.

For employers: how does it work?

1. Sign up with a PGA (Payroll Giving Agency)

A PGA is an organisation that facilitates the secure transition of funds from your employee's gross wages to their nominated charity's bank account. You must sign up with a PGA to participate in Payroll Giving. You can view a list of HMRC-approved PGAs [here](#).

2. Encourage employees to sign up

Let your employees know that they can now support their chosen charity through Payroll Giving and encourage them to complete the sign-up form shared by your PGA and send them to your Payroll Department.

3. Let the donations begin!

Your Payroll Department will send the payments and forms to the PGA each month who will pay the charity directly on your employees' behalf.
